DORMANT ACCOUNTS

April 12th is the transaction deadline for accounts that are 3 years dormant. Pennsylvania laws state that any account that is inactive for 3 years is considered to be escheat or abandoned monies and it must be turned over to the state by the end of business April 15th. Do not let the state take your hard earned money!

Check your account for dormancy!

IRA WITHHOLDING NOTICE

Payments from your IRA are subject to federal income tax withholding, unless you elect no withholding. You may change your withholding election at any time prior to your receipt of a payment. Your withholding election does not effect the amount of income tax you pay. You may incur penalties under the estimated tax rule if your withholding and estimated tax payments are insufficient. You may be required to pay estimated taxes even if you elect withholding.
